wishes to cancel the performance with required notice, all monies except for the deposit will be refunded to the "Client," Whereas without required notice, the Client remains liable for the total amount. If the "Performance Group" cannot perform for such reasons as death, sickness, accident, Force Majeure or any other legitimate condition beyond the control of the "Performer(s)," we will provide a substitute Performer or group, and if this is not possible all monies received will be returned to "Buyer." This agreement is to be governed and construed in accordance with the laws of the State of South Carolina. In the event that the performers have to retain the service of an attorney for collection of money owing under the terms of this contract, the buyer shall be liable for attorneys fee's and costs. This contract is therefore considered by both said parties to be legal and binding in accordance to the conditions set forth herein.
